## DR. JOHN A. LATSCHAR

## Reinterpreting Gettysburg: Lessons from the Civil War



In March the Civil War Round Table of Milwaukee will be visited by Dr. John A. Latschar, Superintendent of Gettysburg National Military Park. Dr. Latschar's presentation will focus on connecting the Gettysburg of the past with the present.

John Hope Franklin once described the art of history as "connecting the dots. The more dots that are connected," he explained, "the better the history." For the past decade, that's been the mission at Gettysburg National Military Park — connecting more of those dots.

But John Hope Franklin was also speaking of another kind of connection — the art of connecting visitors of today with the bygone past, with which they have little under-

standing or familiarity. To be truly effective, historians need to find points of connection between the present and the past. Without those connections, history truly does become irrelevant. If we can find parallels between the feelings and experiences which are familiar to the present – the hopes, dreams and fears of today — and if we can show how the same hopes, dreams and fears influenced the past, then we can establish a feeling of familiarity, of recognition, of understanding — that those distant folks of the past are just like us — trying their best to cope with the complexities of their world.

Dr. Latschar, in his presentation, will be telling a double-sided story. First, how they are striving at Gettysburg National Military Park to connect the historical dots, so that they may tell their visitors a more complete, a more balanced, a more nuanced story of how this nation descended into and emerged from the hell of the Civil War. And second, how they are striving to connect their visitors of today to those events from the past — so they can better understand how those events influenced the development of our nation and so that a better understanding of the decisions made in the past may help us make better decisions today and in the future.

Dr. Latschar has been the Superintendent of Gettysburg National Military Park since 1994. He is responsible for the long-term strategic planning as well as day-to-day operations for the battlefield and the Eisenhower National Historic Site. His responsibilities include coordination with local organizations and officials, state agencies and members of Congress. He maintains close working relationships with organizations that contribute to and support the National Park Service's efforts at Gettysburg.

Dr. Latschar is a 30-year veteran of the National Park Service and has been recognized by the NPS for his leadership numerous times. He earned his B.A. and M.A. in history from Kansas State University. He was awarded a Ph.D. in American History from Rutgers University in 1978. He is a combat veteran of the Vietnam War, serving in action there in the U.S. Army during 1970-1971. He retired from the U.S. Army Reserve as a Lieutenant Colonel in 1994.

Under Dr. Latschar's stewardship, the battlefield rehabilitation project returned the Gettysburg landscape as close as possible to its 1863 appearance. A new Museum and Visitor Center, funded through donations coordinated by the Gettysburg Foundation, opened in Spring 2008 and a renovated Gettysburg Cyclorama, opened to the public in September 2008.

## **Latschar Stays on as Superintendent**

Gettysburg Superintendent, Dr. John A. Latschar will remain in his current post, reversing his decision to retire and become president of the Gettysburg Foundation. Latschar made the decision following advice by Department of the Interior ethics officials that the move would severely curtailed his ability to work with the park in his new position.

"When initially approached to consider heading the Gettysburg Foundation, Superintendent John Latschar did what any responsible federal employee should do," said National Park Service Northeast Regional Director Dennis R. Reidenbach. "He contacted National Park Service ethics officials, and he also contacted me as his supervisor."

When initially informed by the Washington office in October 2008 that there was no ethical issue in accepting the position, Latschar announced his retirement. Subsequently, Department of Interior ethics officials issued supplemental guidance because of Latschar's involvement in developing agreements between the Foundation and the NPS.

Current Foundation president, Robert C. Wilburn, will postpone his departure from the Foundation until a successor is found and named by the search committee.

"I had been looking forward to the challenges of moving to the private sector and working for the Gettysburg Foundation," said Latschar. "However, I can't complain about going back to the best job in the National Park Service as Superintendent of Gettysburg NMP and Eisenhower NHS. We'll now redouble our efforts to make our wonderful partnership with the Gettysburg Foundation the best that the National Park Service has ever seen."

On March 4, 1861, Abraham Lincoln was inaugurated as the sixteenth President of the United States. Lincoln was ushered into office facing the crisis of a split nation. In his inaugural speech Lincoln argued that the Union could not be dissolved and that any secession resolves and ordinances were void – that acts of violence against the authority of the United States were "insurrectionary or revolutionary." Lincoln noted that there need not be bloodshed or violence and that there would not be any "unless it is forced upon the national authority."

In your hands, my dissatisfied fellow countrymen, and not in mine, is the momentous issue of civil war. The government will not assail you. You can have no conflict, without being yourselves the aggressors. You have no oath registered in Heaven to destroy the government, while I have the most solemn one to preserve, protect and defend it.

On March 4, 1865, Abraham Lincoln concluded his second inaugural address with words of hope and inspiration:

With malice toward none; with charity for all; with firmness in the right, as God gives us to see the right, let us strive on to finish the work we are in; to bind up the nation's wounds; to care for him who shall have borne the battle, and for his widow, and his orphan — to do all which may achieve and cherish a just, and a lasting peace, among ourselves, and with all nations.

Patricia Limerick will deliver the 17th annual Frank L. Klement Lecture at Marquette University on March 24, 2009, at 7:30 p.m. Her lecture is entitled: "The Ownership of the Public Lands. The Romance of Local Control meets the Romance of Expertise."

Dr. Limerick is Professor of History and Director of the Center of the American West at the University of Colorado. She is the author of several books, including *Desert Passages: Encounters with the American Deserts* (1985); *The Legacy of Conquest: The Unbroken Past of the American West* (1987), an overview and reinterpretation of Western American history that has stirred up a great deal of both academic and public debate; and Something in the *Soil: Legacies and Reckonings in the New West.* Limerick has become a well-known public intellectual as the author of op-ed columns for the New York Times and other publications and as a frequent guest and expert commentator on NPR and for documentaries on the American West.

Later this year the Klement Lecture will feature Allen Guelzo, two-time winner of the Lincoln Prize. The lecture on October 1, 2009, is sanctioned by the Wisconsin Lincoln Bicentennial Commission and is open to the public. The following day, October 2, 2009, Marquette University Law School will sponsor a one-day conference examining Lincoln and the Constitution, Lincoln and Politics, and Lincoln the Lawyer.
