# An Underwater Look at Monitor

USS *Monitor*, the US Navy's first ironclad warship, foundered in a storm off Cape Hatteras on the last night of 1862. Our October speaker, Dr Robert Zaworski, has participated in several salvage dives on *Monitor*.

On March 9, 1987, the 125<sup>th</sup> anniversary of the battle between USS *Monitor* and CSS *Virginia*, The Mariners' Museum was designated the Principal Museum for the *Monitor* National Marine Sanctuary under the management of the National Oceanic and Atmospheric Administration (NOAA). The Museum cares for the *Monitor* Collection, which includes all artifacts re-

covered from the site as well as a large collection of historical material and scientific data generated by NOAA expeditions to the site. The *Monitor* Collection is maintained by the Museum's Research Library and is available for research by students, the general public, and the professional community under procedures consistent with those in effect at the National Archives and those of The Mariners' Museum.

During June 17 to 30, 2004, NOAA's National Marine Sanctuary Program (NMSP) and the U.S. Navy conducted an expedition at the Monitor National Marine Sanctuary to examine and document the condition of the wreck and to retrieve equipment left at the site following recovery of the turret in August 2002. The expedition was a cooperative effort involving the NMSP, USS *Grasp*, Mobile Diving and Salvage Unit Two, and The Mariners' Museum.

## Fall Classes at the Institute for Civil War Studies

**Tuesday Oct. 5**: George Armstrong Custer's First Last Stand -- George Armstrong Custer is one of America's most famous or infamous military figures. But it was the battle of June 11, 1864, at Trevilian Station where Custer's leadership was shown to be predictive of his life and career. "Custer's Luck," which finally abandoned him some 12 years later at the Little Big Horn, was not luck but pluck and gallantry. His Michigan Brigade followed him into and out of the "jaws of hell." The instructor is David G. Coverdale, BS, MS, SPHR, an instructor at Marquette University, MSOE and The Management Association. He is a lifelong student of the Civil War.

**Tuesday, Nov. 2:** The Confederate Raiders -The War Against Northern Shipping. From 1861 to 1865, in a time-honored tradition that was legally somewhere between legitimate economic warfare and piracy (depending on point of view), the Confederate raiders not only stalked the Seven Seas, but also the U.S. coastline from Maryland to Maine. Typified by ships such as *Alabama, Florida,* and *Shenandoah*, the Rebel raiders were almost everywhere, and the Northern effort to hunt them down, stop them, or deny them targets were just as dogged as the gray-clad corsairs themselves. Instructor John Beatty is an avid military historian and researcher working on a master's degree in Civil War studies.

All classes meet from 7 to 9 p.m., carry one CW Unit, and the fee is \$60. # 2005 Klement Lecture on October 25th, 2004

The 2005 Klement Lecture at Marquette University will feature William Blair, Associate Professor of American History and Director of the George and Ann Richards Civil War Era Center at The Pennsylvania State University. He is also the editor of *Civil War History*, the leading scholarly journal in the field. Prof. Blair's lecture is entitled: "Why Didn't the Confederates Hang? The Debate over Post-war Punishment of Former Rebels," and is drawn from his current research on the aftermath of the Civil War.

The lecture will be held on Monday, October 25, at 7:30 in Marquette University's Alumni Memorial Union, Room 227. The lecture is free and open to the public and will be followed by a reception.

Blair has published several books on the Civil War era, including Virginia's Private War: Feeding Body and Soul in the Confederacy (1998), A Politician Goes to War: The Civil War Letters of John White Geary (1999--co-edited with Bell Irvin Wiley), and, also co-edited, Making and Remaking Pennsylvania's Civil War (Pennsylvania State University Press, 2001), which won the award as best book on Pennsylvania History from the Pennsylvania Historical Society. Prof. Blair was awarded the Allan Nevins Prize for Best Dissertation in American History by the Society of American Historians. At the lecture the History Department will be presented with the annual Klement Donation from the Civil War Round Table. The Klement Donations, named in honor of the late founding member Frank L. Klement, are used by the Graduate program at Marquette to defray expenses of budding American History scholars to present papers at symposia and otherwise jump-start their careers.
